- 1) Register your school. Enter all of your Director Info,
- 2) Then go to the correct Marching entry section, and enter the requested info,
- 3) Print a Form #1, and mail to the address listed above. Please include a copy of the new invoice (Form 1A) for our files. No need to send by Certified Mail. However if you prefer to use "Delivery Confirmation", for your peace of mind, feel free.

**NOTE: YOU ARE STILL REQUIRED TO POSTMARK YOUR ENTRIES ON THE APPROPRIATE ENTRY DEADLINE DATE.**

The following forms must be completed:.

- A. ONE copy of the Official Certification Form No. 1 (buff colored) must be prepared , signed by the Principal. Attach to it a roster listing all personnel of the competing group in alphabetical order. These forms can be mailed in with your entries or hand delivered to the Contest Chairman prior to contest performance.
- B. **The following form will be printed by the Exec. Secretary & delivered to the contest chairman:** **Three copies** of the Region Marching Contest Evaluation Form No. 2 must be prepared for each organization entering competition. (salmon colored paper)

Please read your 2008-2009 U.I.L. Constitution and Contest Rules Book for all information concerning Region Marching Contest, Area Marching Contest, and the State Marching Contest.
